3. Higher Education as a Node in the Global Valorisation of Capital


- Universities are no longer *outside* capital; they are *within* its circuits of accumulation sites where human capacities are commodified, indebted, and managed.
- Higher education operates as part of capital's global infrastructure: producing labour-power, innovation, and legitimacy for accumulation.
- In semi-peripheries, universities are inserted into dependent circuits subordinated to global hierarchies of knowledge, funding, and recognition.









